Section 3

Schedule 4 Applications

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. A range of qualifying criteria have to be met, with approval at the Traffic Commissioner's discretion. An important consideration in the process is any environmental history relating to the subject operating centre or any potentially adverse environmental impact resulting from the transfer. Legislation prevents any statutory objection against the Schedule 4 element of an application.

New Applications (Section 3.1): where the Traffic Commissioner has given a direction that the provisions of paragraph 2 of Schedule 4 shall apply, objections may only be lodged against the published application under Section 12(1)(a) of the 1995 Act, disregarding the suitability of the operating centre for use as such by the applicant as set out in Section 13(5)(d) of the Act;

Variation applications (Section 3.2): where the Traffic Commissioner has given a direction that the provisions of paragraph 4 of Schedule 4 shall apply, objections may again only be lodged against the published application under Section 12(1)(a) of the 1995 Act **unless** that transfer can be accommodated without any overall increase in the existing overall vehicle/trailer authorisation on the receiving licence, in which case there is no statutory requirement to publish details of that application. **Section 3.3** does however detail any such applications in order that interested parties are made aware of changes to authorised operators at listed operating centres
